AS A MAJOR INDICATOR OF SUCH CAPACITY BUILDING, THE SOTENI PEOPLE ON THE GROUND IN KENYA EITHER MANAGED OR OBTAINED 5 PROJECT GRANTS FROM A VARIETY OF FUNDERS DURING THIS PERIOD. WE CONTINUED THE SOTENI-P&G CLEAN WATER PROJECT, WHICH ENABLES IN-HOME PURIFICATION OF DRINKING WATER. 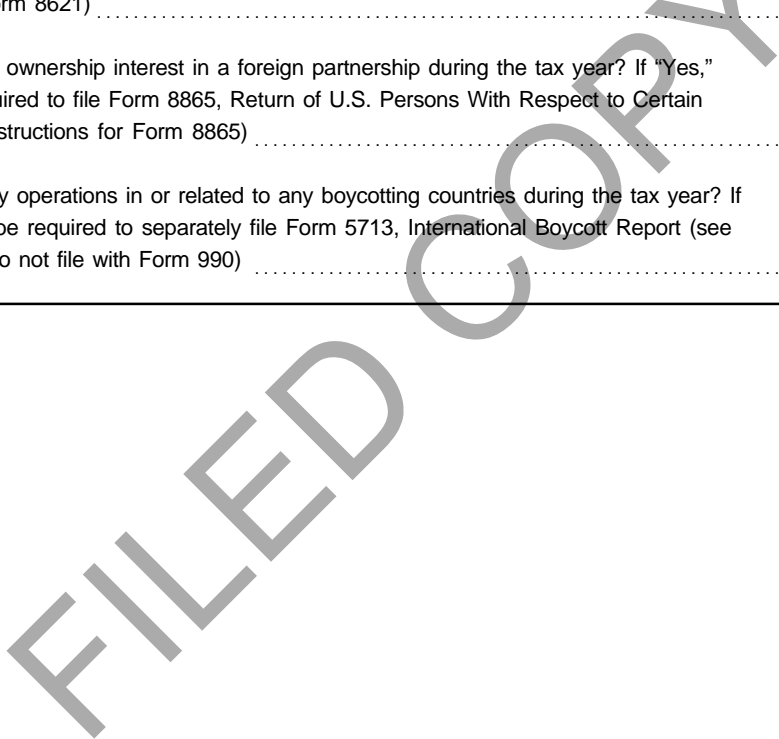
