AS A MAJOR INDICATOR OF SUCH CAPACITY BUILDING, THE SOTENI PEOPLE ON THE GROUND IN KENYA EITHER MANAGED OR OBTAINED 5 PROJECT GRANTS FROM A VARIETY OF FUNDERS DURING THIS PERIOD.
