FOR THOSE THAT TRAVEL TO KENYA WE OFFER THE OPPORTUNITY TO WORK CLOSELY WITH THE LEADERS ON THE GROUND ON PROJECTS AND TO ALSO LERN OF A DIFFEERENT CULTURE. WE HOPE THEY WILL BECOME AIDS PREVENTION ADVOCATES HERE IN THE USA AND IN KENYA.

SOTENI CLUBS: SI WORKS WITH HIGH SCHOOL STUDENT-RUN CLUBS WITH EDUCATIONAL INFORMATION ABOUT HIV/AIDS, SOTENI, AND KENYA. CLUBS RAISE MONEY, COLLECT CLOTHING, AND ACQUIRE MEDICAL SUPPLIES TO SEND TO THE VILLAGES OF HOPE. SI OFFERS THIS EXPERIENCE TO GIVE STUDENTS A VEHICLE IN WHICH TO WORK LOCALLY AND THINK GLOBALLY.
